### **UNDISPUTED FACTS**

- Petitioners provide abortions in Iowa. App. I to Mot. for Summ. J., Aff. of Jill Meadows, M.D., in Supp. of Pet'rs' Mot. for Temporary Injunctive Relief ("Meadows Aff.") at A002; App. I to Mot. for Summ. J., Aff. of Abbey Hardy-Fairbanks, M.D. at A017–018.
- Embryonic or fetal cardiac activity is detectable as early as six weeks into a pregnancy, measured from the first day of the last menstrual period (lmp). Meadows Aff. at A003.
- 3. A six-week embryo is not viable (in the sense of being capable of sustained survival outside of the pregnant woman's uterus). *Id.* at A002 (current 20-
