Dear Michael,

Under Iowa Code Chapter 22, I request the following public records:

1. A list of all nonprofits or for-profit entities for which Governor Reynolds has donated time with her, and/or a meal or private tour at Terrace Hill, for a fundraising auction from May 24, 2017 to the present. My understanding is that such a list has been distributed to one or more journalists.
2. Copies of written correspondence related to scheduling or making arrangements for any meals or tours at Terrace Hill involving winners of charity auctions and their guests.
3. Records showing food and staffing costs for each event at Terrace Hill involving winners of charity auctions and their guests.
4. Records showing who covered the costs of food and staffing for any events at Terrace Hill involving winners of charity auctions and their guests.
5. Records related to any legal opinion (whether produced within the office of the governor or from an outside attorney) on the practice of the governor donating her time and/or the use of Terrace Hill space to a private for-profit or nonprofit organization.

To reduce printing and photocopying costs, and to facilitate social distancing, I request that these records be provided in electronic format and sent to me via email.
