COME NOW the Petitioners, the American Civil Liberties Union of Iowa and the League of United Latin American Citizens of Iowa, by and through the undersigned counsel, and respectfully submit this statement of undisputed facts pursuant to Iowa Rule of Civil Procedure 1.981 in support of their Motion for Review on the Merits, filed herewith.

#### **Undisputed Facts**

- The Secretary of State promulgated the administrative rule 721—28.5 (47, 48A) (Noncitizen registered voter identification and removal process) in the Iowa Administrative Bulletin on August 8, 2012 (ARC 0272C) and in revised form on February 20, 2013 (ARC 0616C).
  (Appendix exhibits 1-3, pp. 1-8).
- 2. IAC Rule 721—28.5 took effect on March 27, 2013. (Appendix Exhibit 1, p. 2).
- 3. Respondent Secretary of State Schultz has entered into a memorandum of agreement (MOA) with the U.S. Citizenship and Immigration Services to access the federal SAVE system to implement IAC Rule 721—28.5, which MOA was executed and became effective August 14, 2013. (Appendix exhibit 4 pp. 9-20).
